The European Union of Judicial Officers (UEHJ), in cooperation with our partners, the European Foundation of Judicial Officers, the School for lawyers in Paris, the European Institute of Public Administration (Luxemburg), the Fondazione Scuola Forense Vittorio Emanuele Orlando (Italy) and the Order of Solicitadores in Portugal has received financial support of the European Commission to develop training for legal professionals on EU law.

Currently we have set following trainings:

- Linguistic Training (English) : 6-7 May 2021
- Train the Trainer program on EU Judicial cooperation in civil and commercial matters: 21-22 June 2021
- Train the Trainer program EU Civil procedures : 6-7 October 2021
- Train the Trainer program EU Judicial cooperation in family law: 27-28 January 2022

We would like to invite the colleagues from your country to apply for these trainings.

The participants are expected to follow all sessions. A **minimum of 85% attendance** is necessary for completion and certification.

Requirements to candidates:

- Subject-matter Expertise: candidates for trainer are recognized as experts in the field of enforcement legal knowledge, enforcement practice, cross-border enforcement etc. and viewed by peers and superiors as someone who performs excellently and has a solid conceptual and organizational understanding of the functioning of the enforcement system in a national and international context;
- II) Language Proficiency: An excellent command of written and spoken English language is required (level B2). The trainings will be conducted in English.
- III) Motivation: pursue the objective of developing structured training programme/s for enforcement agents and other target groups, increasing their competences and professionalism; motivated by the opportunity to contribute to the professional development of colleagues and enhancing cross-border cooperation, improving the overall functioning of the enforcement of judgments in Europe;
